Before quoting rate, intending bidder should inspect the materials. **The date of inspection is between Tuesday, the 19th July, 2016 & 21st July, 2016 from 11.30 A.M. to 1.30 P.M.** While lifting the materials, objection from successful bidder regarding quality, quantity etc. will not be entertained.
2. The offered price of damaged materials should not be below the reserved price.
3. The rate should be on lump-sum basis in both figure & words irrespective of items to be disposed.
4. Overwriting/erasures/changes in offered rate will not be considered unless it is authenticated.
5. **An earnest money amounting to Rs.5,000/- (Rupees five thousand) only should be deposited through Bank Draft payable at Kolkata on any nationalized bank in favour of the undersigned. The original draft is to be attached along with sealed tender.**
6. **Self attested photocopies of 1) Electors Photo Identity Card (EPIC) of the bidder issued by the Election Commission of India; 2) PAN Card and 3) Trade License issued by the competent authority are to be attached along with offer otherwise the offer will be rejected.**
