The Director of Animal Husbandry & Veterinary Services, West Bengal on behalf of the Governor of West Bengal invites online bids only from Reputed Hatcheries or from Breeding Farms or from Reputed Supplier having experience in this field for zone wise rate contract of twelve months for supply of 50 lakh to 1 Crore (Approx) Day Old Chicks & Day Old Ducklings of undernoted specification upto Block Level(Delivery Point) across the State of West Bengal(2nd call)

1. Age of chick / Duckling: Day Old.
2. Percentage of mortality: Nil.
3. Breed Variety in case of Day Old Chicks (DOC)–Straight Run-RIR (Rhode Island Red), LIT [(i) Rainbow-Rooster (ii) Shipra (iii) Indbro Brown Layer or any other approved breeds of LIT varieties] and in case of Straight Run Day Old Ducklings (DOD) – Khaki Campbell.
4. Minimum Body Weight of DOC shall be 32 grams and that of DOD is 40 grams.

1. Offered rate should remain valid for a period of **Twelve Months** from the date of acceptance of the tender and any extended period, if situation arises.
2. Earnest Money of Rs.1,00,000/- (One Lakh) shall have to be submitted as per the manner stated in Finance Department Order No. 3975-F(Y) dated 28-07-2016 [copy at Anneure-III] unless the bidder is exempted under orders of the Govt of West Bengal or of the Govt of India. Exemption Certificate, if any, shall have to be uploaded in the EMD folder of statutory documents. Bidders are also advised to submit EMD of their bid well in advance to avoid technical snag./delay in electronic processing of the payment of EMD. EMD in mode other than the mode prescribed above will not be accepted.
3. After publication of the N.I.T. in the newspapers, detailed catalogue along with terms & conditions, BOQ (Bill of Quantity) may be obtained from the Website <http://www.wbtenders.gov.in> at free of cost & can also be viewed from the Website <http://www.darahwb.org>
4. The bidder has to submit declaration regarding authentication of variety/breed of chick/duckling and vaccination of parent stock. (Annexure-‘IV’)
5. The bidder should have a minimum annual turnover of Rupees Fifty lakhs in any two years of last three years which has to be substantiated by IT Return for the two financial years among last three financial years i.e. 2016-17, 2017-18 & 2018-19.
6. Scanned Original PAN, Trade License and Check List are to be uploaded.

7. The bidder must not have been blacklisted/ debarred/de-registered/banned by any State Govt. /UT Govt. / Central Govt. or its agencies. Necessary declaration in the form of Affidavit shall have to be submitted.
8. Declaration towards time required for supply has to be uploaded which should be not later than 45 (Forty-five) days from the date of placement of order(Annexure-‘V’)
9. Scanned Original Registration Certificate (for co-operative societies and/or SSI units).
10. Tenders will be floated in two parts –
 - a) Technical Bid for technical proposal (mandatory documents in Statutory & non-statutory cover) and
 - b) Financial Bid for quoting zone wise rate inclusive of all taxes in BOQ.
11. The bidder can quote rates for more than one approved variety of chick.
12. Submission of online tender may be made by the bidder with the help of Digital Signature Certificate (DSC).
13. The software shall make automatic encryption of the technical bid as well as financial bid. No one will be able to open these two bids prior to schedule date & time as fixed by the undersigned.
14. After evaluation of technical bid, those who will technically qualify, their financial bid will be opened for evaluation.
15. Disclosure of rate other than BOQ will disqualify the bidder.
16. Online bid submission will start on **23rd November, 2019 at 3 pm** in the e-tender portal viz. <http://wbtenders.gov.in>.
17. Pre bid meeting will be held on **27th November, 2019 at 12 noon at Pranisampad Bhawan, LB-2 , Sector –III, Kolkata -700106.**
18. Online bids in two parts i.e. Technical Bid (Part-I) & Financial Bid (Part-II) are to be submitted on, **13th December 2019 till 5 pm** for the aforementioned N.I.T.
19. Technical bid Opening Date is tentatively fixed on **16th December 2019 at 11am**. Other activities i.e. date of uploading ,list of technically qualified bidders, date of opening of financial bid etc. will be communicated later on.
20. The above schedule is fixed; however, the undersigned reserves the right to change the date of activities in case of any exigencies through a notice in the departmental website viz. www.darahwb.org& at the Notice Board at above addressed office.
21. All applications to be duly filled in and to be submitted with supporting documents required for technical bid.
