Sub: Forfeiture of Earnest Money Deposit (EMD)/Bid security deposit and forgo the right to participate in future tenders for a period of 2 (two) years for suppression of facts and providing false declaration against this Directorate NIT # WBARD/DRUG/NIT-2/T-633/22-23, dated 26.05.2022 [Tender ID: 2022 ARD 382421 1] for supply of Drugs & Medicine.

Whereas, this office invited e-tender vide NIT No.: WBARD/DRUG/NIT-2/T-633/22-23, dated 26.05.2022 [Tender ID: 2022\_ARD\_ 382421\_1] for supply of Drugs & Medicines where it had been clearly mentioned that declaration of the bidder having "5 (five) years manufacturing and marketing experience" in the form of an Affidavit from Class-I magistrate and notarised by a Notary (Annexure-VII) on non-judicial stamp paper worth Rs. 10/- (NIT clause 5.6, Sl. 5, NIT Page- TC 3) should be uploaded.

### And

Whereas you made declaration on 10.06.2022 that your firm M/s Safecon Lifesciences Pvt. Ltd. was having 5 (five) years of manufacturing and marketing experience in the Notarised Affidavit on non-judicial stamp paper worth Rs. 10/-. But it was observed that you uploaded one manufacturing license in Form-25 vide Number of licence and date of issue is 04 of 2018 and 22.02.2018 respectively and, it was also observed that you uploaded another manufacturing license in Form-28 vide Number of licence and date of issue is 03/SC/P of 2018 and 22.02.2018 respectively and, it was observed that you uploaded one more manufacturing license vide Number Drug/7371/2661(1-2), Lucknow dated 16.03.2019.

### And

Whereas, a show cause dated 20<sup>th</sup> April, 2023 vide this office No. 1509/DARAH/PUR/T-633 issued to you, asking why Clauses - 5.1 and 6.1 vide NIT No.: WBARD/DRUG/NIT-2/T-633/22-23, dated 26.05.2022 [Tender ID: 2022\_ARD\_ 382421\_1] and relevant penal measure(s) will not be invoked against you as from the above facts it is clear that your firm did not have 5 (five) years of manufacturing and marketing experience as on 10.06.2022. This kind of misleading declaration by violating the NIT clauses -27.1, 4.1, 4.2 attributed to serious concern for us.

### And

So, considering all and after receiving your unsatisfactory reply and after application of mind, the Bid Security Deposited/Earnest Money Deposited amounting to Rs.2,00,000.00 (Rupees two Lakhs) against e-tender NIT No.: WBARD/DRUG/NIT-2/T-633/22-23, dated 26.05.2022 [Tender ID: 2022\_ARD\_ 382421\_1] is hereby forfeited, and your right to participate in future tenders under the Animal Resources Development Department, Government of West Bengal has forgone for a period of 2 (two) years for suppression of facts and providing wrong declaration in the notarised Affidavit on non-judicial stamp paper as per clauses – 27.1, 4.1, 4.2, 5.1 and 6.1 of the NIT with an effect from the date of issue of this letter.
